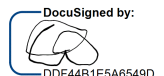

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, CENTRO DE INTEGRAÇÃO EMPRESA ESCOLA DE MINAS GERAIS (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. ### **Getting paper copies**

### **Withdrawing your consent**
